a. I, for myself and as agent for those who will utilize the space which I have rented and/or any user or participant in any related CFH clinic, practice, league or other event HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE CFH, their officers, official agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasers"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM MY OWN NEGLIGENCE OR OTHERWISE to the fullest extent permitted by law.

ARBITRATION AND CLASS ACTION RESTRICTION: Customer hereby agrees to resolve any and all disputes arising out of this contract which through binding arbitration and further to handle each potential dispute. Any dispute arising out of this contract shall be resolved by arbitration administered by the American Arbitration Association ("AAA") in accordance with the rules of the "ADRAMARYLAND" and shall be held in Adams, Maryland. Judgment on the part of the arbitrator may be entered in any court having jurisdiction thereof. By agreeing to this decision of the arbitrator is final the parties understand that they each waive their right to have such disputes resolved by trial by jury.
